**28** Preserve Archaeology features have been preserved and protected during all the planting operations at Mission Garden. Visitors to the Garden are informed about the remaining archaeology that is evidence of previous generations cultivation of the site. Water usage has been minimized to preserve sparse supplies with efficient irrigation and water harvesting. Honor The Friends of Tucson's Birthplace have hosted and taken part in many celebrations and events honoring Tucson's cultural heritage. Mission Garden has hosted numerous public events including tours by 400 Garden Writers of America, a tour by Boy Scouts, honoring Donas with the Davis Mariachi, Tree Stewards event to honor donors, Tucson's Birthday Fundraiser, celebrating opening of Luis Gutierrez Bridge, celebration of Santa Cruz Valley Heritage Foundation. The Friends also have weekly volunteer workdays and are open for public tours. Accessible paths have been built to allow all visitors to tour the Garden. Protect The historical character of Mission Garden has been maintained by appropriate selection of trees, plants, and building materials. Many of the plants and cacti have been rescued for protection from other construction projects. Restore 2012 Was the first year of the Friends as developer and operator of Mission Garden. Advisory committees of experts have been formed to guide the Friends in developing Mission Garden. Spanish Orchard has been recreated with the planting of 121 heritage fruit trees, Planting of the Native Plant Area has been initiated and will serve to demonstrate and educate visitors on the foods gathered from the desert. A Winter Garden was planted to grow Mission-era crops. Crops and seeds from the Winter Garden have been shared with the community. Promote the cultural heritage. Workshops for the community have been held to demonstrate tree planting, pruning, care & maintenance of trees. Construction of Spanish era & Native American style ramadas has educated volunteers and community visitors in historic materials and methods. Planting of grapes has been an experiment in determining the best varieties and pruning methods to establish a heritage vineyard. Educational materials have been developed and over 130 volunteers take part in Garden activities. The Friends have also made many presentations to promote honoring Tucson's heritage, and over thirty organizations have partnered in the development of Mission Garden.
