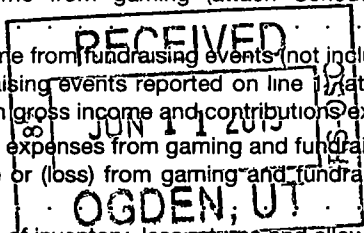

Panza is also working toward building Quixote Village, a permanent supportive housing facility that will consist of 30 very small cottages and a community building that will contain showers, laundry facilities, a communal kitchen, and living and meeting space. The village idea came from the founders of Camp Quixote, and the Village design is the product of Camp residents' meetings with a team of pro-bono architects. During 2012 Panza made significant progress in both improving conditions in the Camp, and preparing to build the Village. Thurston County has agreed to provide a 1.6 acre site for the Village, and fund rasing for the Village construction is well underway. We will be breaking ground in June 2013 and moving into the Village by Christmas 2013.
