Case Management services provide individualized assistance with employment, continuation of education, housing referrals, supportive counseling and aid with obtaining benefits. Sarahs Circle provides a variety of educational programs on topics pertinent to women who are homeless. Program topics include domestic violence, all aspects of health, physical, emotional and mental, and advocacy
