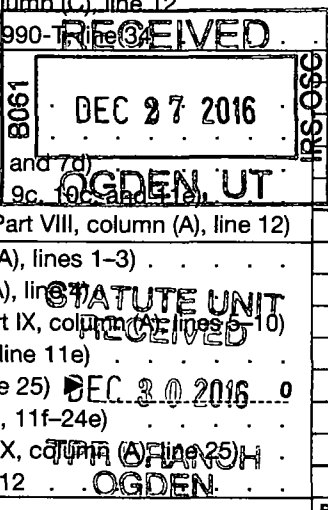

In accordance with its charitable purposes, Church Women United in Blacksburg organizes voluntary collections of school children for the United Nations Children's Fund. The entire amount collected is sent to the U.S. Fund for UNICEF, which is tax exempt under section 501(c)(3) of the Internal Revenue Code and has no affiliation with Church Women United in Blacksburg. UNICEF is a humanitarian and developmental agency seeking to break the cycle of inequity and poverty with programs of prenatal care, clean water, sanitation, health care, and education, among others, especially for the most disadvantaged children.

4b (Code:) (Expenses \$ 957 including grants of \$ 841) (Revenue \$ 876)
Three "celebrations" (worship services) are combined here because they are similar, with prayers, hymns, Biblical reflection, and an offering. The revenue listed here consists of the offerings of individuals in attendance and from local participating churches. Except for the cost of the supplies for the celebrations (\$116 covered six celebrations), revenue was donated to organizations that are tax-exempt under section 501(c)(3) of the Internal Revenue Code. For completeness, these organizations are: To the affiliated organization, Church Women United, U.S.A., \$166.56 (including \$36.16 for the Fellowship of the Least Coin for reconciliation and for development projects benefitting poor women and children); to the affiliated organization, Church Women United in Virginia, \$66.50; to the Women's Resource Center of the New River Valley (services for victims of domestic violence), \$142.50; to each of the following organizations, \$66.50: Church World Service (to help the poor), NRV CARES (local child-abuse prevention), Free Clinic of New River Valley (health care for low-income residents), Blacksburg Interfaith Food Pantry, Valley Interfaith Childcare Center (for children of low-income parents, Christmas Store (for low-income families), VA CARES (services for people transitioning back into society after completing penal sentences).
