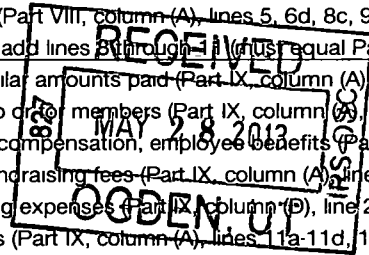

DURING THE TRADITIONAL ACADEMIC YEAR.
