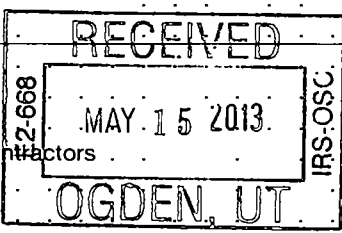



Junket, Inc. has between 15-25 youth in its program, and some of the activities have been focused towards assisting the youth in giving back to their community, such as making Thanksgiving Baskets full of food for their neighbors, buying Christmas gifts for children in need, and hosting a bake sale to raise money for the New York City AIDS Walk. Junket Designs, a community based project, was formed as a small business enabling the youth to manage the company and build leadership skills as a result. They have created their own products, two t-shirts and a tote bag with their inspired designs, to sell as a way to raise money for their chosen charity. Moving forward, Junket, Inc. will continue to assist the youth in building the business of Junket Designs, introducing new original products in the fall of 2013. Junket, Inc. will continue to recruit individual mentors to assist the youth in their transition from foster care into independent independent living. This assistance will include, but not be limited to, educational support, job readiness assistance, and general life skill building.
