 The SMART Recovery Self Help Network's mission is to help people recover from all types of addiction and addictive behaviors, including drug abuse, drug addiction, substance abuse, alcohol abuse, gambling addiction, cocaine addiction, prescription drug abuse, and problem addiction to other substances and activities. SMART Recovery sponsors face-to-face meetings around the world, daily online meetings as well as an online message board and 24/7 chat room.

 SMART Recovery Online (SROL) - SROL offers online meetings, active message boards and a 24/7 chat room to assist individuals desiring to overcome addictions. The meetings and related online services teach self-empowerment, self-reliance and tools and techniques for self-directed change. During the year ended December 31, 2012, approximately 1,350 online meetings were held serving over 45,000 meeting participants. Message board registrations averaged 1,100 individuals each month. Participation in the 24/7 chat room continues to grow. SROL revenues totaled \$19,200 for the year ended December 31, 2012 and are included on lines 1f and 8c in the Statement of Revenue (Part VIII).

 Bookstore - SMART publications are sold via our online bookstore and over the phone.

 Distance Training - SMART Recovery face-to-face meeting facilitators and online facilitators and volunteers are required to participate in our monthly Distance Training program. The training is provided via a Moodle delivery platform and almost all study is completed online, with one meet-and-greet meeting, a role play and a final meeting with the President as each session concludes. During the year ended December 31, 2012, 591 registered for training, 330 graduated and 24% started meetings before the end of 2012.
