RAINN OPERATES THE NATIONAL SEXUAL ASSAULT HOTLINE (800 656 HOPE) AND THE NATIONAL SEXUAL ASSAULT ONLINE HOTLINE (a secure web-based support hotline at online RAINN.ORG). RAINN also operates the DOD Safe Helpline, services for members of the US military affected by sexual assault, through a contract from the department of defense. All services are provided free to victims of sexual assault.

Public Education. RAINN educates the public about sexual violence, working with national media and the entertainment industry to ensure that accurate information is communicated. Through an annual college program and other community activities, RAINN also recruits, trains and mobilizes volunteers to teach at-risk populations about sexual assault prevention and recovery.
