

BLACKMAN JONES: IN 1997, PARENTS OF STUDENTS WITH DISABILITIES BROUGHT TWO CLASS ACTION LAWSUITS AGAINST D.C. PUBLIC SCHOOLS (DCPS) CLAIMING THAT DCPS VIOLATED THE FEDERAL LAW KNOWN AS THE INDIVIDUALS WITH DISABILITIES EDUCATION ACT (IDEA). IN THE FIRST LAWSUIT, KNOWN AS BLACKMAN, PARENTS STATED THAT AFTER THEY REQUESTED DUE PROCESS HEARINGS, HEARINGS WERE NOT HELD AND HEARING DECISIONS WERE NOT ISSUED ON TIME.

IN THE SECOND LAWSUIT, KNOWN AS JONES, PARENTS STATED THAT ONCE THEY RECEIVED HEARING DECISIONS OR ENTERED INTO A SETTLEMENT AGREEMENT WITH DCPS, DCPS DID NOT PROVIDE ALL THE SERVICES THAT HAD BEEN ORDERED OR AGREED TO. THE JUDGE PUT THE TWO CASES TOGETHER TO MAKE ONE CASE KNOWN
