Festival Events & Programming - APC produced two main programs during the year: Stonewall Month and the Atlanta Pride Festival. During Stonewall Month, APC partnered with a number of local businesses and nonprofit organizations to produce 22 events during June 2012. An estimated 4,300 people attended these events which included educational and social programming to commemorate the 42nd anniversary of the riots at the Stonewall Inn. During the Atlanta Pride Festival, over 250,000 people attended social, entertainment, cultural, and visibility programming in and around Piedmont Park on October 13 - 14, 2012.
