International Sponsorship Program: She's the First allocated funding to sponsor the annual tuition of more than 150 female students in our eight partner schools, located in Tanzania, Uganda, Ethiopia, South Sudan, Kenya, India, Nepal and Guatemala. Each year of education for a girl increases her future wages and increases the chances that she will break the cycle of poverty affecting her family and community, and ultimately increasing the GDP of her nation. Our sponsorship program is based on a 100 percent model, meaning that all donations from the general public go directly to sponsoring girls in our partner programs. She's the First fundraises separately for operating and U.S. programming costs.

Campus Leadership Summit: She's the First mobilizes students across the United States to fundraise for girls' education sponsorships through a structured campus chapter network that receives ongoing support from our team of post-graduate volunteers. In October, to coincide with the first United Nations International Day of the Girl, She's the First held its inaugural Leadership Summit in New York City for our most engaged student leaders, providing two days of intensive leadership training and problem-solving workshops on international education issues. She's the First spent approximately \$15,000 to cover the base costs of participation for more than 30 student attendees. Afterwards, these leaders returned to their high schools and university campuses, doubled the funds raised from the previous year to sponsor girls' education and earned prestigious awards for their service. Additionally, their work, shared on social media outlets, inspired peers on other campuses to apply for She's the First chapter status, expanding the number of girls sponsored through She's the First

India Documentary: She's the First traveled to Shanti Bhavan, our partner in India, to attend the graduation of a few of our scholars. While there, volunteers taught research workshops and interviewed directors, students, and parents to perform due diligence checks and strengthen our partnership. Finally, they filmed a short documentary that was released and is continuously used for fundraising and awareness activities by both campus chapters and supporters at large.
