Caregiver Respite Program: provided non-acute, non-medical in-home caregiving services to 500 homebound seniors and seniors with chronic illnesses and/or disabilities by matching them with trained volunteers. Services included phone reassurance calls, home visits, errands which include grocery shopping, light house keeping, home safety repairs, bill paying, meal preparation, MediCal application assistance, information, and referral. Provided more than 13,000 phone reassurance calls, and more than 2,500 home visit hours.

4b (Code:) (Expenses \$ 47,994 including grants of \$ 103,574) (Revenue \$ 109,016)

Ride with Pride Program: provided curb-to-curb, door-to-door, and door-through-door rides for ambulatory seniors who do not drive. Rides can be for medical appointments, mental health or other social service appointments, errands or leisurely activities. Total one-way rides: 6,250.

4c (Code:) (Expenses \$ 50,991 including grants of \$ 30,659) (Revenue \$ 31,159)

Senior Peer Counseling Program: provided in-home peer counseling to 20 homebound seniors and their family caregivers dealing with early or mide mental health issues, such as depression, sadness, loneliness. The program also provided group counseling to 53 seniors dealing with grief and loss, stress due to caregiving, and the impact of isolation (2 groups in two cities -- each with 3 10-week cycles.
