Garden City Harvest is now in its seventeenth year of operation. While our programs are diverse and our reach is broad, we are focused and determined in our efforts to build community through agriculture. Garden City Harvest provides farming and gardening opportunities that restore and empower people. We offer a hand up to those in need, providing healthy, delicious produce to those who might not otherwise have access. We encourage children to learn about and certainly to taste vegetables, and in so doing, perhaps develop better eating habits. We help teens struggling with their own self-worth realize their value to others as they give back to the community. We grow produce with and for people with low incomes. In 2012, we saw an increased interest in our Community Gardens with almost 100 families on the waiting list to rent plots, and another 50 waiting this year. This is due in part to a general growing interest in gardening and local sustainability. Since last season, we've been busy meeting and planning with existing and potential new partners. We expanded the Northside and Meadow Hill Community Gardens this summer and plan to add a new site in 2014. We offer education and training in ecologically conscious agriculture at every opportunity. Be it a educational farm field trip for first graders, hands-on farming for college interns, or teaching community gardeners how to control flea beetles without the use of toxic pesticides. Our Farmer in the Classroom program, now entering its third year, will be offered to second graders in all nine MCPS Elementary Schools. Throughout the school year, our farmers help these children explore connections between agriculture and their everyday lives. We use our farms and gardens for the personal restoration of youth and adults. It's no secret that digging in the dirt has therapeutic value. Each season we employ at-risk teens who learn basic farming skills, make significant and meaningful connections within the community, and gain self-confidence as they make their way toward adulthood. This season three of last year's teens returned as Youth Harvest Interns, learning leadership skills and helping introduce a new group of teen farmers to this work. One of the interns participated in a national youth leadership conference, where he gave a presentation on his work with Garden City Harvest. Garden City Harvest is committed to grow, feed and inspire through work that unites us and connects us to one another, as we celebrate, work and learn on the land.
