The Touchet Valley Arts Council promotes fine arts in the Touchet Valley and surrounding area including, but not limited to, music, art, film, oral interpretation and theater. The Liberty Theater presents current and classic movies, produces live community theater dramatic and musical shows, and hosts additional youth theater activities and civic events throughout the year.

Film/Cinema Presentations:
Our film/cinema presentations were very successful, showing more than 48 first-run, children's, and classic movies during the year. Community residents in our remote and rural community in Eastern Washington, appreciate and enjoy the films presented. We maintained reasonable and reduced admission prices to make it affordable for many who would not otherwise be able to enjoy this kind of recreational activity. Most of our films are intended for general family viewing with popular matinee showings. Special film showings accompany seasonal fundraising events for Christmas and other holidays. During the year we prepared for conversion of our cinema equipment to digital format. Community support fundraising was successful for this major upgrade.

Live Theater Productions:
We produced live productions throughout the year. Our Fall Musical involved more than 60 volunteer community theater cast and crew who contributed more than 4,000 hours of volunteer effort for a very successful show. More than 1,100 theatergoers attend the show on 11 showdates before and after the Thanksgiving holiday. Our Spring Variety Show involved more than 50 community cast and crew members. An additional production of the musical comedy "Nunsense" was presented to sell-out crowds. Our children's program featured another production brought to us by The Missoula Children's Theater, again to sell-out crowds. All of these live shows are attended by local community members and guests who often travel more than 100 miles to see our shows.

Educational and Community Forum:
Our theater also functions as a community forum for events put on by other local groups and institutions such as, a Candidate's Forum sponsored by the League of Women Voters, a staff leadership training by our local hospital district, and youth organizations. We may charge a nominal fee for use of the facility to defray costs for these activities. Our theater lobby displays a continuing rotation of artwork of local artists to display their paintings and sculpture to the community.
