RIVER LEADERS: Conservation simply cannot happen without people. Without a caring, committed community of citizens, protecting and restoring rivers over the long term is not possible. It is critically important to build stable and sustainable river or "watershed" organizations that can remain effectively engaged for years. For that reason, River Network has always invested heavily in "capacity building" efforts with local groups so that they can plan more strategically, operate more efficiently and fundraise more successfully. Groups that we train have more staff, more donors and more volunteers. Most importantly, these groups are also more effective in protecting rivers and watersheds! CONTINUED ON SCHEDULE O.

RIVER RALLY: River Network and the Waterkeeper Alliance joined forces for the first time to organize and host the largest River Rally ever! From May 4-7, more than 750 watershed leaders from 44 states across the U.S. and 15 countries gathered together in Portland, Oregon, to build new momentum toward addressing the challenging water issues that confront our nation and our planet. Participants represented 343 nonprofit organizations, 35 local, state and federal public agencies, three foundations and 25 companies. Featured speakers included Alexandra Cousteau, Robert F. Kennedy Jr. and EPA Administrator Lisa Jackson. Top-notch professionals provided 159 hours of enriching learning experiences through more than 100 workshops and intensive half-day sessions.

RIVERS AND HABITAT: Fish and other wildlife that depend on rivers, lakes and freshwater wetlands are going extinct four to six times faster than other species. Woods, marshes and other natural places along rivers - and sometimes rivers themselves - have been paved over, drained or otherwise destroyed. Too many fertilizers in our rivers are causing serious pollution problems in the Great Lakes and the Chesapeake Bay, and a massive "dead zone" in the Gulf of Mexico. CONTINUED ON SCHEDULE O.

Key 2012 Accomplishments include:

* Thanks to the ongoing efforts of our Urban Waters project, the Duwamish River Cleanup Coalition in Seattle has grown its staff from 1.75 to 3.5 FTEs, while expanding its board and upgrading its website and fundraising databases; Groundwork Buffalo has raised more than \$50,000 in new grants for brownfield redevelopment, stormwater education and the installation of rain gardens; and the Village Creek Human & Environmental Justice Society in Birmingham is hiring paid staff for the first time. In all, groups in 15 cities throughout the U.S. benefited from our training and are becoming more effective voices for restoring some of America's most troubled urban rivers.

* Our new IMPACT project is helping providing 15-20 local groups in areas of high poverty (LA, MS, AL, DC, MI, OH) become more effective local advocates by providing each group with 40-80 hours of 1:1 consulting assistance over an 18-month period in addition to their participation in customized webinars and peer learning opportunities.

* In all, we provided one-on-one training in the areas of Strategic Planning, Fundraising, Leadership Transitions, Board Development and other organizational best practices to more than 150 organizational leaders from river groups throughout the U.S., with a particular emphasis on the Great Lakes and the Chesapeake Bay regions.

Key 2012 Accomplishments include:

* In the Clinton River watershed near Detroit, a River Network "Learning Lab" continued its innovative work to pioneer ways that wetlands, rain gardens and other "no-concrete" solutions can "re-green" our cities and absorb polluted urban runoff while providing more cost-effective alternatives to concrete culverts and costly water treatment facilities.

* We launched a new Learning Lab near Milwaukee, Wisconsin and identified two rural watersheds where we will be working with local farmers to test different strategies for increasing the size and number of riparian buffers as a means of reducing phosphorus runoff.

* Our new Learning Lab in Oregon has identified five potential restoration sites on a suburban reach of the Willamette River near Portland where we will be working with private and public landowners to

RIVERS AND COMMUNITY: In 2012, River Network granted more than \$135,000 to local organizations in support of over sixty on-the-ground projects in 23 states. These efforts to ensure healthier rivers and watersheds engaged thousands of citizens and included river and lake cleanups, development of new waterway access sites, restoration plantings, invasive species removal, building rain gardens and installing rain catchment systems, implementing green infrastructure to reduce flooding, and involving youth in water quality monitoring and classroom-based science curriculum. In addition, River Network awarded more than \$150,000 in scholarships (reduced registration and/or direct travel subsidies) to assist grassroots watershed leaders in attending River Rally 2012. These grants and scholarship awards are made possible through the generous investments of our public.

RIVERS AND ENERGY: Half of the fresh water in our nation's rivers is already flowing into our power plants - essentially being used as an industrial coolant. Meanwhile, 13% of the electricity we generate is used to treat, heat and pump water. In a warming world, this cycle of ever-greater consumption of water and energy threatens to spiral out of control. Fortunately, communities have the power to make smarter energy development choices, conserve water and energy and, in so doing, reduce the impacts of climate change.

*Our Peer Learning Network provided 18 local watershed groups from all across the U.S. with a series of webinars, individual mentoring, and assistance on messaging that helped advance their water and energy efforts locally.

* We published a new report "Burning our Rivers: The Water Footprint of Energy" that documented the inefficiencies of using finite water resources for thermo-electric (coal, nuclear, gas) power generation and the benefits to both water quantity and water quality from shifting to "water-friendly" sources such as Photovoltaic solar and wind.

RIVERS AND HEALTH: Having abundant water means little if it's not safe to use. * Researched and authored the forthcoming "Physician's Guide to Toxic Exposures and Disease" - a succinct yet comprehensive overview of the most recent research that demonstrates a connection between environmental exposure to toxic substances and disease.

* Conducted lab analyses of fish in the Columbia River near Oregon that found contaminants present at levels several thousand times higher than
