


LEGAL AID PROVIDES CIVIL LEGAL SERVICES TO THE POOR IN AREAS SUCH AS DOMESTIC VIOLENCE, HOUSING, INCOME MAINTENANCE AND CONSUMER-RELATED ISSUES. APPROXIMATELY 270 VOLUNTEERS ASSIST IN THE CAMPAIGN'S ACTIVITIES.
