HIGHLY TRAINED STAFF USING SPECIAL HEARING TECHNOLOGY, SUCH AS COCHLEAR IMPLANTS, DIGITAL HEARING AIDS, FM SYSTEMS, AND ADVANCED COGNITIVE TEACHING STRATEGIES ASSIST YOUNG DEAF AND HARD OF HEARING CHILDREN REACH THEIR FULL POTENTIAL BY DEVELOPING AGE APPROPRIATE LISTENING AND SPOKEN LANGUAGE SKILLS. THE TWO SCHOOLS FUNCTION INDEPENDENTLY BUT SHARE THE SAME EDUCATIONAL MODEL. BOTH ARE CONSIDERED MODELS OF EXCELLENCE IN HIGHLY EFFECTIVE EARLY INTERVENTION IN DEVELOPING LISTENING AND SPOKEN LANGUAGE AND COGNITIVE COMPETENCIES IN YOUNG CHILDREN WITH HEARING LOSS. THE RESULTS OF THIS INTENSIVE EARLY INTERVENTION IS THAT MOST STUDENTS ENTER THEIR MAINSTREAM SCHOOLS WITH AGE APPROPRIATE LANGUAGE SKILLS BY KINDERGARTEN, READY TO BE EFFECTIVE LEARNERS ALONG WITH THEIR HEARING PEERS.
