ACHA Program 2013

Heart to Heart Activities

Heart to Heart Ambassadors: ACHA expanded the Heart to Heart Ambassador Program, an initiative that provides ACHA patient and family members with personalized information and support. In 2013, 12 new Ambassadors were trained, bringing the total to 51 Ambassador volunteers. These volunteers offered over 960 ACHA patient and family members personalized information and support. This is a 60% increase over 2012.

Heart to Heart Where You Are: ACHA launched a regional pilot program with selected ACHA Ambassadors and adult congenital heart disease clinics hosting informal education meetings. Four meetings were held in 2013 – Chicago, IL; Orange County, CA; Portland, OR; and Philadelphia (Delaware Valley), PA. The goals of each meeting were 1.) to offer face-to-face support to CHD patients and families and 2.) to assist the clinics in outreach and education for patients and families. Approximately 120 patients and family members were served.

ACHA Webinar Program: The ACHA webinar series continues to educate CHD patients and families by presenting webinars on various interesting and timely topics. More than 1000 ACHA members attended 13 different webinars in 2013. In addition, webinars are available ongoing on the ACHA website and have had close to 2500 views in 2013. National experts spoke on a wide range of topics including *Understanding Genetic Testing and Hereditary Risk in ACHD; Pulmonary Hypertension in Adults with CHD; Coping with Life's Challenges and Changes; What Adults Living with Ebstein's Anomaly Need to Know and Insurance Update for the CHD Patient : Looking Ahead to 2014.* Webinars also covered topics such as ACHA advocacy and research.

Lifelong Care Campaign: In 2013 ACHA Ambassadors and staff presented on the importance of lifelong cardiac care at over 22 events. These included 3 Mended Little Hearts meetings, a community health fair, hospital cardiac care meetings and 18 Congenital Heart Walks, a partnership with The Children's Heart Foundation. Hundreds of CHD patients and families received this carefully crafted message.

ACHA Discussion Forum: A benefit of ACHA membership is the ability to participate in the online Discussion Forum. More than 8100 members have access to this forum as a means to discuss issues with other members in the ACHA community and to provide and receive support in a moderated and safe environment. There are more than 900 topics and 90,000 posts.

ACHD Program Directory: In collaboration with the International Society of Adult Congenital Heart Disease, ACHA expanded its online listing to more than 113 ACHD clinics in the United States and Canada; the directory continued to be the only resource of its kind available in the United States.

ACHA Online and Printed Materials: ACHA provides its members with resources for specific congenital heart defects as well as associated medical conditions and common psychosocial issues. In 2013 eight educational pieces were created or updated, including printed educational handouts “Guidelines for the Management of Adults with Congenital Heart Disease: Highlights for Parents and Families” and “Q&A: Tetralogy of Fallot.”

ACHA Facebook Page: ACHA continued to use Facebook as a way to inform and interact with the congenital heart disease community. ACHA Facebook membership increased steadily through the year, from 1,905 people to 2,793 by year’s end – an increase of 46%. Visit the ACHA Facebook page at www.facebook.com/AdultCongenitalHeartAssociation.

ACHA Website: The ACHA website, www.achaheart.org, serves as the main portal for information, and there were more than 96,000 visits to the website in 2013. This included more than 52,000 unique visitors, accounting for nearly 295,000 page views.

ACHA Blog: The ACHA Blog continues to be one of the most popular parts of the ACHA website; in 2013 we published 140 posts from more than 15 bloggers, which were viewed approximately 45,000 times. ACHA bloggers post on a variety of topics relevant to the CHD community, and included posts such as “An Open Letter to ACHD Cardiologists,” “This CHD Patient Will Marry You For Your Health Insurance,” and “The Art of Coping.”

Congenital Heart Walks

Congenital Heart Walk Program: Congenital Heart Walks are a joint effort between the Adult Congenital Heart Association and The Children’s Heart Foundation to unite the congenital heart disease community to fight to make a difference. The walk is a way for all of those affected by CHD to help raise vital funding and awareness. In 2013, the Congenital Heart Walk’s fourth year, more than 50,000 walkers raised more than \$1.3 million in 27 locations across the United States from California to Florida and Texas to Minnesota. Professional Programs

Provider Action for Treating Congenital Hearts (PATCH): In partnership with the American College of Cardiology (ACC), PATCH aims to engage and educate community and general cardiologists by increasing awareness of the ACC/AHA care guidelines, increasing general cardiologists' awareness of when referral to an ACHD provider is needed plus increasing collaboration between ACHD and non-ACHD healthcare providers in order to promote and provide high-quality ACHD care to patients around the country.

In 2013 ACHA hosted 5 webinars targeted to both adult congenital heart disease and general cardiologists including "Pulmonary Artery Hypertension in the Adult with Congenital Heart Disease" presented by Michael Earing, MD, FACC, "Discussing Pregnancy and Birth Control with your CHD Patients" presented by Arwa Saidi, MB, BCh, FACC, and "Bicuspid Aortic Valve and Associated Arch Obstructions – What the Health Care Provider Should Know" presented by Stephen Cook, MD, FACC.

Members of ACHA's Medical Advisory Board presented on adult congenital heart disease care and guidelines at the state chapter meetings of the ACC in Michigan, Ohio and California. The PATCH website was also maintained for webinars and other professional materials.

Congenital Heart Disease Training Fellowships: In 2013 ACHA developed an application and review process to offer training awards to two institutions with a commitment to high-quality adult congenital heart disease (ACHD) care. These awards will fund one fellowship at each institution with a requirement of ACHD leadership and mentoring throughout the award period. Funding priority will be given to new and emerging ACHD training programs. Awarding of the two fellowships is in process.

Advocacy Activities

National Congenital Heart Advocacy Day: More than 113 advocates from 26 states gathered in Washington, D.C., on March 13, 2013 to talk to their lawmakers about CHD. Hosted by the Adult Congenital Heart Association and Mended *Little* Hearts, this annual event brought together patients, family members, medical professionals, and supporters from across the country to connect with more than 120 legislative offices.

Lifelong Surveillance of Congenital Heart Disease Initiative: ACHA has been working closely with strategic partners to help define the surveillance needs and strategies for the adult congenital heart population. The 2013 federal budget appropriated \$2 million to the CDC for CHD surveillance, as outlined in the Congenital Heart Futures Act. This money was used to provide three grants supporting pilot projects to develop adolescent and adult surveillance strategies.

Congressional Congenital Heart Caucus: The formation of the Congressional Congenital Heart Caucus in 2012, initiated by ACHA advocacy efforts, is an informal group of members of Congress dedicated to issues related to congenital heart defects. We are grateful to Congressman Gus Bilirakis, who serves as the founding chairperson of this caucus. In 2013 seven more members of the House of Representatives were added, raising the total number of members to 22.

Insurance Coverage, Social Security Disability and Compassionate Allowance Program: ACHA has advocated tirelessly for affordable care for adults with CHD. Compassionate Allowances (CAL) are a way of quickly identifying diseases and other medical conditions, allowing Social Security to target the most obviously disabled individuals.

In 2013 ACHA added to the website a significant expansion of information for patients and families explaining various medical insurance options, how to obtain insurance through the Affordable Care Act, and resources to help them navigate the health care insurance system.
