Medical Program - In 2013, LWB's medical program provided surgeries for 127 children from 16 provinces and 37 orphanages. Twenty-four rural children received surgery through the Unity Fund, which provides surgeries for children from impoverished families. Healing Homes - In 2013, LWB operated four healing centers in China, the Hearbridge Healing Home, in partnership with the New Hope Foundation, which cared for 31 extremely fragile babies, many in critical condition, the Starbridge Healing Home, helping babies with a wide variety of medical needs, the True Children's Healing Home, with an emphasis on babies born with anal atresia, and the Anhui Healing Home, which cared for babies born with cleft, prematurity, and congenital heart defects

Foster Care Program - In 2013, LWB opened new programs in Shangrao, Jiangxi and Guiyang, Guizhou. LWB had foster programs in 19 Chinese cities in 2013, serving 347 children. Eighty-four children in our program were adopted domestically and internationally

Education Program - In 2013, 242 students were enrolled in LWB Education programs, including our Believe in Me Schools which are built inside of orphanages to bring the gift of education to children with medical needs, tuition assistance programs, and LWB's Secondary and Higher Education Program, which helps students attend high school and college. A healthy dental project was begun in our Believe in Me Schools
