The Rockland County YMCA is able to accomplish its mission through twenty-seven PROGRAM SITES AND ITS MAIN BUILDING IN NYACK The Early Childhood Programs provided affordable child care for over 205 children at 3 centers including Young Children's center and Y's Beginnings Pre School programs in Suffern and Sloatsburg In addition, there are more than 1,001 children and 709 families a year served at the Family Court Child Care Center at the Rockland County Court House in New City The School Age Child Care Department operates before and after school child care programs in 16 sites The program serves nearly 1,174 children in 4 school districts including Clarkstown, Ramapo Central, South Orangetown, and Nyack It also offers a summer program for 47 youth at its main building in Nyack The Aquatics Department provides a variety of programs including water exercise classes for older adults and those with disabilities, lifeguard training and swimming lessons There are 741 children and 112 adults who are learning to swim at the YMCA progressive swim program The Fitness Department provides instruction on using strength and cardiovascular equipment and offers health enhancement classes for teens, adults and seniors to promote physical fitness and well being Programs for youth and adults include fitness classes, karate and youth sports including soccer, basketball, volley ball, tennis, fencing and rowing which develop skills and promote team work There are 28 pre-school children, 123 youth and more than 100 adults being served The Dance Department provides creative movement and dance classes for 280 youth to develop coordination and self confidence The Youth and teen Department operated a summer teen program for 47 teens, a Girls Mentoring Program for 12 Middle school girls and an after school teen leaders club The YMCA conducts teen nights for 225 Middle School and High School students on Friday and Saturday nights The Youth Government Program has 93 teen participant in a legislative and judicial program to develop leadership skills, public speaking and promote good citizenship in cooperation with local high schools The North Rockland Program Department operates after school child care programs at 5 schools for 185 children in the K-7th grade in the North Rockland Central School District The YMCA also opened the Y's Beginnings Preschool at the Haverstraw Central Presbyterian Church, which serves 29 preschool children A Summer Camp in Pamona which served 85 Campers from K - 6th grade The YMCA Membership Department is located at the Nyack facility which provides member services in gymnasium, swimming pool, aerobic studio, fitness center and game room The YMCA offers many activities that strengthen families such as, Family Fun Nights and Healthy Kids Day at its main facility The YMCA serves 5,100 members and 1,517 program participant members Sixty percent of YMCA members are youth and teens In 2013 1,564 youth and 74 adults of low income families received \$210,637 of financial assistance for memberships and to take part in YMCA programs, thanks to generous contributions and public support Financial assistance is available for those who can not afford to pay the full cost of membership or programs
