RIGHTS OF PASSAGE/SUPPORTIVE APARTMENT - PROVIDES TRANSITIONAL HOME SERVICES FOR UP TO 18 MONTHS FOR YOUTHS, WHICH INCLUDES EDUCATION, JOB PLACEMENT, AND HOUSING In our transitional living program, a youth takes the initial steps in living independently To qualify for the program, a youth must be in school or working full-time If working, they are required to put a portion of their wages into savings In addition, the transitional living program offers classes for basic life skills such as cooking, banking, money management, health issues and communication Our Los Angeles campus has 24 beds for this program and the Bay Area has twelve Additionally, Covenant House California has five off-site apartments that house ten youth who are in the final steps of living independently The youth pay a portion of the rent and bills while still having the "safety net" of CHC If needed, they are given guidance and support from our staff (Currently only available in Los Angeles)
