 In-school Module-based Teaching (Program in progress since 2002) For this program, Science from Scientists has designed hands-on, activity-based modules in STEM (science, technology, engineering, and mathematics) complementary to regular school curricula Modules incorporate national and state standards and have been designed to contain a lecture segment and a hands-on laboratory segment We have developed modules in biology, chemistry, earth science, and physics on many topics the students would not yet typically see at school Our staff members go into the schools during the school day - or in after-school programs in the case of some partnerships - and teach our modules to students in grades 4-8 When possible, Science from Scientists also organizes and sponsors field trips to local science museums The primary goal of this program is to spark the students' interest in science, and to complement classroom curricula thereby helping students prepare for the Massachusetts Comprehensive Assessment System (MCAS) As part of the in-school program, Science from Scientists is a PDP Provider for the teachers of the classes who receive our In-School Module-Based program Teachers are given the opportunity to earn 10 or 20 professional development points throughout the time Science from Scientists teaches in their classroom In order to earn points, teachers must design lesson plans that complement the Science from Scientists modules and must demonstrate an understanding of different learning styles in their students We provide the teaching staff and all of the materials The schools pay nothing To date, this is our most extensive program We are working with thousands of students from all around Massachusetts We are currently teaching in numerous middle schools in Everett, MA, and in several schools in Revere, MA We are also teaching in Brookline, Marblehead, Newton, Somerville, Cambridge, and Winchester, MA

 Outreach ProgramsA) CSI ExperienceScience from Scientists creates a comprehensive forensic science mystery for students to explore and solve Students are guided through a fun and informative experience with hands-on activities grounded in a customized storyline B) Public DemonstrationsScience from Scientists staffs booths at various STEM expos and events at which we demonstrate the hands-on segments of some of our modules In addition, this year we began performing Science Theater live on stage at area science festivals The shows are designed to wow an audience of 8-14 year olds with exciting demonstrations of scientific principles, for example, pressure is demonstrated using a bed of nails C) Vacation ProgramsScience from Scientists runs week-long programs during school vacations Our inaugural program was held in August of 2013, and provided participants with a combination of our module-based program, a field trip, and a Science Theater show D) Science FairsScience from Scientists instructors are available to assist teachers and instruct students in grades 4-12 through the science fair process from start to finish Students learn about the scientific method, experimental design, data analysis, and creating an attractive, informative and succnt display We are able to offer schools aid throughout the entire science fair process by administering a science fair, offering additional guidance as tutors, or serving as judges In addition, in FY13 we were engaged to help run the Boston Regional Science Fair for the Boston Public School System We did not aid students in the choice and design of their science projects, instead we assisted only in the organization and running of the day of the fair

 Media and EntertainmentScience from Scientists has developed episodes of an educational television program called The Dr Erika Show to make science accessible and entertaining for elementary and middle school students across New England The show was executive produced by Joshua Seftel, an Emmy Award-winning filmmaker who has produced educational programs for NOVA, PBS and WBGH Its host, Dr Erika, is a 2004 graduate of the Massachusetts Institute of Technology and earned a Ph D in biochemistry from the Boston University School of Medicine in 2012 She was also crowned Miss Massachusetts in 2004 Leveraging Dr Erikas unique background, the show is designed to teach children about science, break stereotypes, and make STEM subjects more approachable and entertaining for children The Dr Erika Show was available on Comcast On Demand as well as online, and has been designed to be used as a complement in school science classes
