The Trustees represent the members at large for all activities of the Association. The Trustees meet monthly as a group and routinely serve on one or more sub-committees that meet separately as often as needed to serve specific functions. Minutes of each Executive Committee and Trustee meeting are recorded by the Secretary, approved by members and preserved in accordance with the Record Retention Policy. Committee meeting minutes are recorded by a Committee member and incorporated into the Trustee meeting minutes during each meeting as a Committee report. Minutes and results of elections, voting, etc. are preserved in Association files pursuant to the Record Retention Policy.

Form 990, Part VI B.11a. Form 990 is reviewed and approved by the BCWA Administrator and the Executive Committee (consisting of the current officers plus the past President) before presentation to the Board of Trustees. The Board of Trustees reviews and approves the Form 990 (by majority vote) before it is filed. A copy of the Form 990 is made available on the BCWA website and at the Annual Meeting for review by all members and is available on request.

Form 990, Part VI B.12c. Beaver Creek Wetlands Association requires that each officer, trustee, employee, and affected member sign a comprehensive Conflict of Interest and Gift Policy and Disclosure form annually. These documents are reviewed and accepted by the Executive Committee (as described above) and retained in vital files. Compensation rate for the BCWA Administrator is established and approved by the Executive Committee, based on current market rates for comparable services and level of responsibility. The Executive Committee reviews the Administrator compensation rate no less often than annually and adjusts accordingly as approved by unanimous consent of the Executive Committee. During 2013, the BCWA Administrator who had served in the same position for over 14 years (Robert Limbert) retired and was replaced by the existing Secretary and Trustee (Debbie Karr). Debbie's compensation level matched that of the prior Administrator reflecting her level of expertise and current job responsibilities. Upon accepting the BCWA Administrator position, Debbie relinquished her position as Secretary but retained her position as Trustee through the remainder of her term. Richard Swigart (Trustee) was elected to fill the Secretary position vacated by Debbie Karr. The Executive Committee and Board of Trustees unanimously approved the appointments. See also Form 990, Part VII.A.1a. line 3, 11, 16.

Form 990, Part VI.C.19. Beaver Creek Wetlands Association policies, charter, bylaws, and governing documents are available in the BCWA administrative office, on the BCWA website (www.beavercreekwetlands.org) and by request. BCWA financial statements are supplied to all members annually, provided via Form 990 on the BCWA website, in the BCWA office, at the Annual Meeting and upon request.

Net Unrealized Gains (Losses) reflects the unrealized gain (loss) on investment securities (Vanguard Short-Term Treasury and Vanguard Intermediate-Term Treasury Funds) held by BCWA. Interest income and dividends on these investments are reflected on Form 990, Part VIII.3 with realized capital gains (losses) on Form 990, Part VIII.7d.

Other Changes in Net Assets reflects the reclassification of amounts related to land improvements on the properties acquired in 2011 under an Ohio EPA program referred to as WRRSP (Water Resource Restoration Sponsor Program) and designed specifically for wetlands acquisition and management. During 2012, the land management expenses were reclassified as long-term land improvements as they permanently and constructively altered the nature and value of the property. Amounts that were expensed in prior periods were capitalized and reported in Part X, line 10c, column B as well as in Schedule D, Part VI, line 1c(b). Land improvements are depreciated ratably over 20 years. Prior period reclassifications discussed above continue to impact Part XI Reconciliation of Net Assets as reported in 2013.
