La Casa Norte's Scattered Site Supportive Housing Program is a Permanent Housing program which provides hard to house homeless families and chronically homeless youth with long term stable housing Clients housed in the program are provided with both housing subsidies and supportive services, which are all required to successfully house these households Support services provided include case management, therapy, nutrition education and referrals to a range of additional services such as health care, substance abuse treatment, mental health, child care, legal assistance, work force development services and educational programming

The Community & Supportive Services Program (formerly the Crisis Center) provides free, accessible, bilingual and culturally appropriate case management and housing advocacy services to families, unaccompanied youth and single individuals who are homeless or at risk of becoming homeless The Community & Supportive Services Program staff work in partnership with clients to obtain and maintain housing stability Its primary subprograms included La Casa Norte's (LCN) rapid re-housing program, its Illinois DCFS client housing stabilization program and LCN's homeless prevention program The program also houses LCN's Digital Divide program, its Food Security Organizing project, and work readiness program for internal clients

Casa Corazon is LCN's unaccompanied homeless youth outreach and engagement project which focuses on connecting homeless youth to services This program provides street outreach, drop in centers and comprehensive case management services to youth and emergency overnight shelter beds for homeless youth between 18 and 24 years of age

The Solid Ground Supportive Housing Program provides safe, stable housing for homeless male youth, age 16 to 21 These young men can stay at Solid Ground up to two years, during which time they benefit from comprehensive case management services focusing on a holistic, strength based approach provided within a trauma informed care and transformative justice model Solid Ground is Chicago's only bi-lingual (Spanish/English), culturally appropriate Latino youth shelter in the city of Chicago

Once eligibility is determined, applications are completed by direct service staff and reviewed and approved by the Program Manager. Payment requests are submitted once application is approved and checks are paid directly to the landlords and utility companies. Long Term Lease Assistance-Every participant requesting to participate in Supportive Housing Program goes through an intake and application processes to determine eligibility based on funder restrictions. LCN signs leases with landlords and participants sign a sublease with LCN. LCN pays rent monthly based on leases, which fall within fair market rent guidelines. Transportation Assistance-Participants requesting transportation assistance meet with Case Managers to assess need and purpose of assistance. Case Managers have access to limited amount of bus passes weekly and must make determinations based on availability of bus passes and priority, with priority given to clients needing assistance for housing search, employment and medical appointments.
