The mission of the Northeast Wisconsin Land Trust is to preserve lands that protect our waters, landscapes, and natural habitats for this and future generations. In 2013, the land trust placed conservation easements on 83.9 acres of upland forested land in northeast Wisconsin, including natural shoreline frontage on the Embarrass River, a Class II trout stream. Northeast Wisconsin Land Trust conducted education activities to promote ecological health and land conservation. Grant funds were raised to purchase another public preserve along the west shore of Green Bay. We monitored all protected properties. Invasive species removal projects were conducted as well as planting projects to restore/preserve habitats. Northeast Wisconsin Land Trust formally participated in collaborations with government and non-government partners to promote ecological health and biodiversity in the Fox-Wolf Watershed, Green Bay and Lake Michigan.
