Part III – Line 28 Child Advocacy Center/Foster Care Visitation Services

The Child Advocacy Center is dedicated to reducing trauma to child victims through an interagency approach which will minimize the number of interviews required, provide specialized on-site medical evaluation and treatment, and provide specialized intervention for ongoing community services. During our fiscal year ended June 30, 2013, 104 children and 26 families were served.

Part III – Line 29 Community Prevention Programs

The Children's Center is committed to protecting the children of Medina County by providing *Darkness to Light's Stewards of Children* training to the Medina County community. Stewards of Children is a revolutionary evidence-based sexual abuse prevention training program that educates adults to prevent, recognize and react responsibly to child sexual abuse, and motivates them to courageous action. The Stewards of Children program is designed for organizations that serve children and youth, and any/all adults interested in protecting children. During our fiscal year ended June 30, 2013, 61 adult clients were served.

Community Outreach programs include our "Adopt-a-Family Program" along with a variety of community service projects. Community Outreach Programs served 1,463 families during our fiscal year ended June 30, 2013.
