Exhibition Programs. The Contemporary Art Museum St. Louis (CAM), a non-collecting institution, is internationally recognized for risk-taking exhibitions of the most provocative, insightful, and urgently relevant contemporary art being made today. In the 20122013 season, CAM presented six Main Gallery exhibitions that featured national and international artists working across different presentational formats. In tandem with the Main Gallery exhibitions, the Front Room at CAM presented a dynamic series of shorter exhibitions featuring the work of emerging and established artists. Additionally, the Museum is committed to supporting talented artists working in the St. Louis region through the annual Open Studios STL program. In total, the Museum featured seventeen artists in the Main Galleries and Front Room, highlighted the work of more than 170 local artists through Open Studios STL, and served 24,175 visitors.

Public Programs. In conjunction with its exhibitions, CAM delivers art education to people of all ages by presenting a diverse line-up of programs for the public that include artist and curator lectures, art-inspired food tastings, film screenings, unique workshops designed for families with young children, and a monthly neighborhood-wide art crawl. CAM's public programs provide ongoing opportunities to attract visitors to the Museum, cultivate interest in art, and engage audiences of all ages. In 20122013, CAM hosted over 80 programs that were attended by 9,621 people.

Education Programs. Finally, CAM remains dedicated to fostering creativity and increasing access to the arts for the young people of St. Louis through free arts education initiatives. From in-depth pre-professional training like New Art in the Neighborhood and Teen Museum Studies to broad school outreach initiatives like ArtReach and the Arts Alive Bus, CAM is proud of the meaningful ways its programs make a difference to St. Louis youth. In 20122013, the Museum's youth education programs served 2,204 students from the greater St. Louis area.
