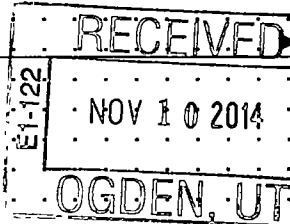

Step Ahead program: \$88,917

Operates through a model of individual assistance and aims to take a comprehensive approach to ending poverty. Social workers, lawyers, psychologists, teachers and support staff work together to support over 500 disadvantaged children. This support includes tuition fees; counselling; and legal advocacy.

Stay in School and other related sponsorships: \$6,700

Sponsorship program providing support to children in Bac Ninh Province at high risk of dropping out of school or who have recently quit due to poverty. There are over 800 children in the program. Support includes school fees; bicycles; and medical insurance.

Safe and Sound Program: \$18,977

Anti-trafficking program in Hue and Dien Bien provinces. We have rescued over 350 children from forced labour or sexual slavery and obtained legal registration papers for over 3,000 children. We support former victims to return to school or vocational training, receive medical assistance and counselling, and we support local governments to enforce policies.

Other programs: \$35,907

Includes administration and communication costs; fundraising campaigns
