We look at a potential student's financial aid package from the school and use a formula to determine their scholarship eligibility based on the cost of attendance and the amount of money the student has to pay. We require all students to make a contribution toward their education of approximately \$4,000 per year, generally financed through loans and work study. ScholarMatch then awards a scholarship for the "gap" after the financial aid and the student's contribution, usually an amount ranging from \$500-\$6,000 for the year. Once this amount is determined, we send the payment directly to the school with a letter stating that it is to be used for tuition/fees and school related expenses for the student. Any remainder, if any, of the scholarship not used by the student is returned to ScholarMatch. After the
