On September 17, 2012, the Florida Division of Elections approved the petition for the Water and Land Conservation amendment. On April 4, 2013, Florida's Water and Land Legacy submitted ten percent of signatures necessary to qualify the amendment for the ballot. The Division of Elections submitted the petition to the Florida Attorney General and the state's Financial Impact Estimating Conference. On April 18, 2013, the Attorney General requested that the Florida Supreme Court review the amendment. On May 23, 2013, the Financial Impact Estimating Conference completed its financial impact statement. On September 26, 2013, the Florida Supreme Court approved the proposed amendment and financial impact statement for placement on the November 2014 ballot. Florida's Water and Land Legacy has collected approximately 660,000 total signatures towards the 683,149 valid signatures necessary to qualify the amendment for the ballot.
