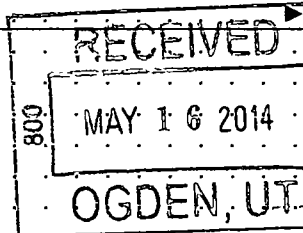

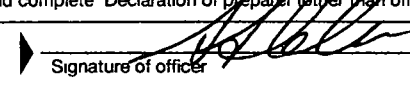

Part III What is the organization's primary exempt purpose?

Community Cats of Palm Coast is dedicated to the practice and promotion of trap, neuter, and return (TNR), to humanely reduce the feral cat population in Flagler County, FL communities. Community Cats of Palm Coast is also dedicated to other means of protecting and benefitting feral cats, such as re-homing programs. The organization has an active TNR unit in which we assist feral cat caretakers in the practice of TNR. This includes supplying traps, instructing caretakers in the trapping process, and arranging for spay and neuter services at special charitable rates by area veterinarians. In addition, our organization serves as a mediator in disputes between neighbors regarding feral cats that result in complaints to Palm Coast animal control. We also have a barn cat program in which homeless cats are relocated to farms in rural areas.
