In 2013, Garden City Harvest saw increases in all of our programs in response to growing demand from the community The Community Gardens program offers people the opportunity to grow food to feed their own families In 2013, we rented 315 garden plots at seven community garden locations, up from 290 plots the previous year In addition, planning began on two new community gardens to be constructed in 2014 In an end-of-year survey, 74% of the community gardeners indicated they were from low to moderate income households and were able to save as much as \$20 per week on their grocery bills by gardening in this way 97% of the community gardeners said gardening improved the quality of their lives overall As part of our Farm to School program, 4,000 students and adults visited our farms on educational farm field trips in 2013 More than 1,000 students participated in structured educational school garden programming Construction took place on a new school garden at Franklin Elementary School in the fall, and planning began for another new garden at Hawthorne Elementary in the spring of 2014 Our Farmer in the Classroom program was expanded to include over 600 second-graders at all nine Missoula District #1 elementary schools in the 2013-2014 school year Through this program, our farmer educators provide hands-on curriculum that encourages second graders to explore connections between agriculture and the food they eat Garden City Harvests four neighborhood farms grew tons (literally!) of produce, making it accessible to everyone, regardless of income level We grew over 40,000 pounds of veggies that were distributed to a number of local service agencies, and to low-income senior citizens through a mobile farm stand We sold CSAs or veggie subscriptions to more people than ever before The farms also served as outdoor classrooms, offering hands-on, experiential learning opportunities Fifteen teens were hired to work on our farms through our Youth Development programs in 2013 In addition, another 25-30 teens volunteered on a weekly basis throughout the growing season The youth all learned to grow food, from seed to harvest, and to cook and prepare healthy meals The Mobile Market continues to be the cornerstone of our Youth Development programs It allows for growth by teaching teens a variety of job and life skills and it allows youth to be involved in a service that others rely on The youth make meaningful connections within the greater community, and seniors gain access to affordable, fresh produce right outside their door Through these interactions friendships form as the two groups share stories and recipes
