GARDEN CITY COMMUNITY CLINIC PROVIDED 4,733 CHARITY MEDICAL, DENTAL AND MENTAL HEALTH ENCOUNTERS TO LOWER INCOME, UNINSURED PATIENTS BY USING VOLUNTEER HEALTH PROFESSIONALS. THIS INCLUDED 3,425 MEDICAL, 670 DENTAL, AND 638 COUNSELING APPOINTMENTS; 1,268 OF THESE ENCOUNTERS ALSO INCLUDED SOCIAL WORK VISITS. OVER 4,600 DONATED OR SUBSIDIZED MONTHLY SUPPLIES OF PRESCRIPTIONS WERE PROVIDED TO PATIENTS. 150 PATIENTS WERE REFERRED ON TO RECEIVE SPECIALTY CARE THROUGH OUR VOLUNTEER PHYSICIANS NETWORK. EXPENSES HERE DO NOT REFLECT \$154K OF DONATED SERVICES ON-SITE VOLUNTEERS; PLUS ANOTHER \$152K IN DONATED LABS & RADIOLOGY.
