Elderhaus assists adults 18 and older to live a quality and independent life to the best of their abilities. The direct care program includes meals, assistance with ADL's, activities and outings. Mentoring and counseling is offered to caregivers. Income sources for Elderhaus include Medicaid waiver, private pay fees, private insurances, veterans administration and the Center Board. In addition grants and foundations provide assistance with general operating expenses, scholarships and other expenses. Fundraising and donations are a small part of income.

Elderhaus owns seven handicapped accessible busses to be used for transporting clients to and from the program and coordinating daily activities.

Many families cannot afford \$65/day and fall short of meeting subsidy assistance. Sliding fees are offered to these families.
