RIVER LEADERS: Conservation simply cannot happen without people. Without a caring, committed community of citizens, protecting and restoring rivers over the long term is not possible. It is critically important to build stable and sustainable river or "watershed" organizations that can remain effectively engaged for years. For that reason, River Network has always invested heavily in "capacity building" efforts with local groups so that they can plan more strategically, operate more efficiently and fundraise more successfully. Groups that we train have more staff, more donors and more volunteers. Most importantly, these groups are also more effective in protecting rivers and watersheds! CONTINUED ON SCHEDULE O.

RIVER RALLY: River Network organized and hosted the 13th annual River Rally on May 17-20 in St. Louis, including a special celebration of our 25th anniversary. More than 430 watershed leaders from 43 states across the U.S. gathered together to build new momentum toward addressing the challenging water issues that confront our nation and our planet. Participants represented 161 nonprofit organizations, 34 local, state and federal public agencies, a dozen Native American tribes, four foundations, three universities and 22 companies. RIVERS AND HABITAT: Fish and other wildlife that depend on rivers, lakes and freshwater wetlands are going extinct four to six times faster than other species. Woods, marshes and other natural places along rivers - and sometimes rivers themselves - have been paved over, drained or otherwise destroyed. Too many fertilizers in our rivers are causing serious pollution problems in the Great Lakes and the Chesapeake Bay, and a massive "dead zone" in the Gulf of Mexico. CONTINUED ON SCHEDULE O.

Key 2013 Accomplishments include:

\* Thanks to the ongoing efforts of our Urban Waters project, groups in 15 cities throughout the U.S. benefitted from our training and are becoming more effective voices for restoring some of America's most troubled urban rivers.

\* Our IMPACT project helped 15-20 local groups in areas of high poverty (LA, MS, AL, MI, OH) become more effective local advocates by providing each group with consulting assistance, customized webinars and peer learning opportunities, with a special focus on developing performance evaluation systems to better monitor and document their impact.

\* We launched a new Learning Lab in the Puget Sound region where we will be working with local citizens on a "Depave" initiative to remove unnecessary pavement from urban areas and return the land to a more natural state as a means of reducing polluted runoff.

\* We published two "What Works" reports summarizing the lessons we have learned in working with state and local watershed groups on water quality monitoring and riparian buffer restoration.

\* Our ongoing work in the Mississippi River Basin included a detailed analysis of state programs that limit the harm of federal actions like the issuance of wetland fill permits or hydropower dam licenses. Our results were summarized in a report and included policy recommendations

Rivers and Community: Over the past two years, River Network granted more than \$100,000 to local organizations in support of over sixty on-the-ground projects in 24 states. These efforts to ensure healthier rivers and watersheds engaged thousands of citizens and included river and lake cleanups, development of new waterway access sites, restoration plantings, invasive species removal, building rain gardens and installing rain catchment systems, implementing green infrastructure to reduce flooding, and involving youth in water quality monitoring and classroom-based science curriculum. We also facilitated a partnership with Bridgestone-Firestone that resulted in more than 35,000 tires being removed from local rivers throughout the U.S. via some 80 river cleanups. Our online Rainbarrel Registry debuted in October and provides a first-ever way for rain barrel owners to share their information and begin documenting the collective impact of home-based rain barrels on saving water and reducing polluted runoff. already flowing into our power plants - essentially being used as an industrial coolant. Meanwhile, 13% of the electricity we generate is used to treat, heat and pump water. In a warming world, this cycle of ever-greater consumption of water and energy threatens to spiral out of control. Fortunately, communities have the power to make smarter energy development choices, conserve water and energy and, in so doing, reduce the impacts of climate change.

Key 2013 Accomplishments include:

\* Partnered with GRACE Communications Foundation on the release of a new report documenting that power plant cooling systems, specifically the outdated "once-through cooling" variety, withdraw 200 billion gallons of water per day, needlessly destroying 2 billion fish and 528 billion eggs and larvae each year nationwide.

\* Worked with state and local leaders in Alabama to build public pressure to close down outdated and water-intensive coal-fired power plants.
