Rivers and Community: Over the past two years, River Network granted more than \$100,000 to local organizations in support of over sixty on-the-ground projects in 24 states. These efforts to ensure healthier rivers and watersheds engaged thousands of citizens and included river and lake cleanups, development of new waterway access sites, restoration plantings, invasive species removal, building rain gardens and installing rain catchment systems, implementing green infrastructure to reduce flooding, and involving youth in water quality monitoring and classroom-based science curriculum. We also facilitated a partnership with Bridgestone-Firestone that resulted in more than 35,000 tires being removed from local rivers throughout the U.S. via some 80 river cleanups. Our online Rainbarrel Registry debuted in October and provides a first-ever way for rain barrel owners to share their information and begin documenting the collective impact of home-based rain barrels on saving water and reducing polluted runoff.
