The WMMC Foundation supports White Memorial Medical Center (WMMC), a 353-bed not-for-profit, faith-based, teaching hospital, which provides a full range of inpatient, outpatient, emergency and diagnostic services to communities in and near downtown Los Angeles One of the greatest assets an organization can possess is the trust of its community internal and external Beyond our role as a leading community health care provider, we are committed to operating as a socially responsible organization meeting the needs of all of our stakeholders our patients, physicians, workforce, neighbors, partners, volunteers and donors This is why WMMC devotes a significant amount of financial and human resources to maintain its legacy of 100 years of community-centered service to medically underserved communities in our area Our goal is to enable people to achieve more than just good health by creating opportunities for growth and development that will make a real, lasting impact on the health of the community WMMC serves a community whose residents are predominantly Latino, where 20% of families earn less than \$15,000 and 38% less than \$25,000 annually, amounts at or well below the federal poverty level As such, we are positioned to provide this historically medically underserved population with highly advanced specialty services, including advanced certifications, specialty care services and state-of-the-art procedures, as well as Latino-focused language programs and education and bilingual doctors and nurses WMMC has adopted rigorous national quality standards and regularly receives various awards and recognitions In 2013, for instance, US News & World Report ranked White Memorial Medical Center #11 in its Best Regional Hospitals Ranking for the Los Angeles Metro Area and #20 in the State of California WMMCs mission anchors everything we do, extending out to the community in many ways Collaborative efforts between WMMC, local organizations and donors has created critical programs needed to address the specific health care needs of the more than two million residents living throughout eastern Los Angeles Together we are changing the outcome of the community's health For example The Cecilia Gonzalez De La Hoya Cancer Center, named for the late mother of professional boxer and philanthropist Oscar De La Hoya, helps address the area's high incidence of breast cancer, featuring sophisticated diagnostic and treatment equipment, bilingual breast cancer support groups, a community resource center and free breast exams and mammograms to uninsured or underinsured women The Diabetes Care Center addresses the high prevalence of diabetes within the community and provides full-service diabetes testing, education, peer counseling and follow-up care and runs a successful Healthy Eating & Lifestyle Program (H E L P) This six-week program is designed to teach children at-risk of developing diabetes the benefits of a well-balanced diet and regular exercise No insurance is needed to access this bilingual program Our at-risk newborns, cared for in one of the few Level III Neonatal Intensive Care Units in Los Angeles, are protected by state-of-the-art technology neo blue lights and our Giraffe Beds, purchased with donations received through the WMMC Foundation Babies are now safer and have a better chance of flourishing because our friends contributed to this successful fundraising effort Nonetheless, a significant portion of the mission-driven assistance WMMC provides its community is intangible or otherwise difficult to quantify The following story illustrates this Diagnosed at the age of 38 with stage four cervical cancer, Anabel Salazar came to Los Angeles, and White Memorial, seeking treatment after being refused medical assistance in the city she lived in because of her immigration status In April 2013 she was admitted for intestinal blockage from complications of the cancer Her 18-year-old son stayed with her and did not graduate from high school after missing three weeks of classes Often he had no money to buy food and would go days without a change of clothes because he didnt have a car or money to take the bus home After spending time with Anabel, we discovered she had a five-year daughter and a 24-year old son Her husband lost his job because he had to take care of the little girl and the oldest son was working in Oklahoma Anabel, her mother, daughter and husband rented a room from her brother-in-law and could no longer pay the rent By the end of April the cancer had spread Her prognosis was very poor The pain increased and as the reality of an inevitable death began to sink in, Anabel asked that we pray for her son and sister to be able to come to spend time with her As the news spread of this heartbreaking journey Customer Loyalty was notified Meal tickets were provided to the family on a daily basis The marketing manager, Sara, heard about Anabels challenges and donated cash and would bring food for the family on a regular basis She also made arrangements and paid for Anabels oldest son, Salvador, to come to Los Angeles Dr Romero, Anabels oncologist, provided a letter to be submitted to immigration for Veronica, Anabels sister, to come to the U S , and Dr Esmail, the Palliative Care Physician, purchased gifts and clothes for Paulette, the five-year old, to celebrate her birthday and kindergarten graduation at WMMC Patty from Education and Training brought the cupcakes and decorations for the celebration The afternoon of Paulettes celebration, Anabel asked that her feeding tube be removed She was ready to die God had answered her prayer her WMMC family, whom she called Angels from heaven, had fulfilled her longing to be treated with dignity and respect, no matter the circumstances She learned the names of the nurses caring for her, including those who cleaned her room, and told them there was a place waiting for them in heaven when their journey on earth was completed Anabel died in June 2013 at the age of 40 With no funds to fly her home, Sara contacted the Mexican Consulate who assisted with funeral arrangements and the flight back to Mexico Sara and Customer Loyalty helped with other donations for Anabels final trip to her home town of Gomez Palacio, Durango We create memories every day, some will-o-the-wisp, some as enduring as we care to remember We are especially grateful to Anabel and her family for allowing us the privilege to walk this journey with them We cant all be cured of disease but we can be healed and made whole Those of us who participated in Anabels journey have been touched and healed in many ways hers is one of the many Whys we do what we do at WMMC Jesus served the poor and calls us to do the same Anabel and her family had no money yet He provided for all their needs as He has called on WMMC to serve its community It takes special people to create change, people with a passion for making a difference in the lives of others and the community at large Not just because it is the right thing to do, but because the passion to help those less fortunate is in their heart and their hunger for excellence White Memorial invites you to partner with us in building on our legacy of primary care and our unwavering pursuit of excellence in quality, innovation and
