Goodwill is a leading provider of job training, career development, and youth programs in eastern and central Massachusetts. These programs help individuals who face barriers to self-sufficiency to develop skills, obtain and keep jobs and create more rewarding and independent lives. In the year ended June 30, 2014, Goodwill's job training programs enrolled 622 individuals considered hardest to employ in programs offering case management, job skills and job readiness training, placement, and post-placement services and helped 237 find jobs. Boston Career Link, the one-stop career center Goodwill operates, assisted 7,540 individuals with career services and referrals to training programs, documented 991 placements and engaged 117 businesses in 185 on-site recruitment sessions. Goodwill's social enterprises provided work experience and a paycheck to 326 individuals in retail, housekeeping and maintenance, and light assembly. (The retail program is described in Part III 4b.) Goodwill's Youth Initiative provided a broad range of opportunities to 138 young people to help them achieve in school, graduate from high school, and transition to college or jobs.









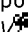


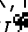




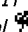

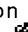

The retail program is a social enterprise that benefits the community by providing job training for individuals with barriers to employment, creating jobs, and selling quality, low-cost goods that help individuals, particularly those of limited means, get the items they need at affordable prices. In the year ended June 30, 2014, Goodwill's retail program operated 11 Goodwill Stores and collected donations at 31 sites located throughout eastern and central Massachusetts. The retail program provided job training and jobs as it collected, sorted, distributed, merchandised and sold donated clothing and household goods. It also provided interview attire and accessories free of charge to 435 job trainees from Goodwill and other community-based job training programs to help them secure jobs, and made clothing and other goods available to local non-profit organizations also serving those in need.
