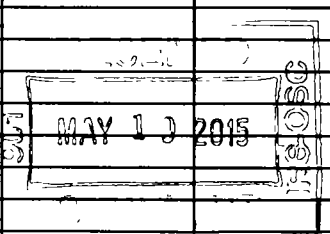

The Foundation owed **\$36,648** to ongoing programs in Venezuela at the end of 2014. These expenses pertain primarily to medical facilities which bill us on a quarterly basis; for contraceptives which we have ordered going forward, and to private sector doctors. Some of these expenses accrue over the course of several quarters or over the entire year, and are totaled up and charged as part of a general reckoning when the year ends. Clinic expenses incurred during the fourth quarter of each year, and various program expenses accumulated over the entire year, are often not completely calculated and paid until the first and second quarters of the following year. This is in part due to the complex and unpredictable currency control system which the Venezuelan government exercises, which leads to calculating and paying the actual costs in dollars after all expenses are summed up in the local currency at the end of the year.

This hands-on directed assistance applies to approximately 80 families, benefiting more than 400 family members in all, with a small model farm offering community participation in sustainable land use and eco-agriculture, introduction of new fruit and other tree crops, alternative (solar) energy and water resource projects, housing and infrastructure assistance, family emergencies and micro enterprise.

#### 3) Brito Community Center and Rural Education: \$5,595

Our community center is the base of our rural programs, and houses a small educational computer center, with a small primary and high school library. The center has been moved upriver to be near the rural high school, and is currently being remodeled. The core of our rural education program at the center includes scholarships for up to 50 rural high school students and 15 community college students who have graduated in our high school program. We also offer subsidized school supplies to low-income rural families at the center and at two other nearby locations. We assist the remote primary through high school of 100+ students with seven teachers and the nearby rural kindergarten that we founded in 2001. We have a small urban computer center with Internet for our scholarship students, which is also used by neighboring low income urban and rural students.

#### 4) Reproductive Health Educational Workshops: \$941

Education and information on sexual and reproductive health, family planning, sexually transmitted infections and diseases, gender-based perspectives, etc., in schools and public health facilities in several counties, to adolescents and young adults both within and outside of the school system.
