CHI increases awareness of congenital hyperinsulinism in order to improve timely diagnosis, especially among medical personnel who have a direct opportunity to detect it, in order to decrease adverse neurological outcomes and death. CHI works with volunteers around the world to spread awareness of the condition, distributes brochures to medical professionals, provides information on the CHI website about the dangers of prolonged hypoglycemia, holds events for the general public, and works with endocrinologists to improve standards of care and early detection of hyperinsulinism. \$13,217

CHI supports research and development to better understand, treat, manage and hopefully cure congenital hyperinsulinism. CHI shares the patient perspective with researchers, members of the pharmaceutical industry to encourage patient-centered treatments. CHI has created a grant program with the Orphan Disease Center of Penn Medicine (University of Pennsylvania). The selective grant is administered by the University of Pennsylvania and the funds support research for better treatments and a cure for hyperinsulinism. CHI is working to develop a patient registry that will include information that will foster research and knowledge of natural history of hyperinsulinism patients. \$24,650
