Project Access Northwest collaborates with the health care community to open doors to medical and dental care for the low income individuals through a distributed network of donated care that assures appropriate access to medical and dental specialty care services

- Project Access Northwest (PANW) links low income uninsured and underinsured King, Kitsap and Snohomish County patients to volunteer specialty providers Working with the community health centers and free clinics, PANW assures that access to specialty care services by providing care management services PANW assures that the client is eligible, that information such as labs and imaging are available at the time of the scheduled appointment Our patients have a lower no-show rate (about 5% compared to 30+% for typical uninsured or Medicaid patients), are more likely to show up on time and be prepared to work with the specialist on his/her care In 2014, 2,744 patients were appointed by PANW for medical services in our three county service area They were served by approximately 1,300 licensed clinicians

PANW links low income uninsured and underinsured King and Snohomish County patients with volunteer dental providers in PANW's network of care In King County, PANW's focus is on complete oral specialty care services, oral health clearance prior to organ transplantation and dentures In Snohomish County, the focus includes oral care services including restorative care In partnership with the community health centers and free clinics, Swedish Community Specialty Clinic and dentists in private practice, PANW provides care coordination services to assure patients are eligible, have a qualifying oral health need and have the pre-visit dental treatment plan In 2014, 2,488 were appointed by PANW for dental services and served by close to 100 dentists and dental clinicians

PANW implemented a Premium Assistance Sponsorship Program developed late in 2013 This program works with WA state residents who are eligible to purchase health care insurance in the Washington Health Benefits Exchange, are not eligible for Medicaid, are low income and unable to afford the remaining monthly premiums even after the federal subsidy via tax credits are applied In 2014, we were able to enroll and maintain health insurance for 115 covered lives for the policy year that began in January and ended in December 2014
