ATTACHMENT TO PART III – Statement of Program Service Accomplishments

The Educational Advocates Reaching Today's Hardworking Students, Inc. (EARTH'S) is a non-profit agency that educates students, empowers parents and engages communities. Our mission is to ensure that each inner-city Philadelphia student, with the help of concerned adults, has the basic skills needed to be successful in a career or in a post-secondary educational institution. Our three largest programs are as follows:

Success Stories

This program introduces youth to positive role models who serve as graduation coaches that motivate and encourage youth to make positive decisions that lead them on the path to a successful, lucrative, legal career.

Project WERC (We Rebuild Communities)

This program shows parents, family and community members the benefit of being actively engaged in the academic achievement of inner-city youth. Parent and community leaders use train-the-trainer workshops to share information about effective civic engagement and the recruitment of others.

Positive Peer Program

This program is an out-of-school time tutoring program that was approved by the PA Department of Education to provide Supplemental Education Services (SES) to low income, low performing youth.

No foreign grants were received. The cost involved in performing these programs was \$13,892 (no separate accounting was made for the programs)
