January 2014: PARTICIPANT INC hosted two performances as part of the Special Effects Festival: On January 11 and 12, with performances of Everything One in the Disc of the Sun, a self-help karaoke opera by Royal Osiris Karaoke Ensemble (NYC). Conceived by Royal Osiris Karaoke Ensemble (Tei Blow & Sean McElroy) and featuring Tei Blow, Siobhan Gandy, and Sean McElroy. Also on January 11 and 12, in the afternoons, we hosted Molly Haslund's (Belgium) CIRCLES - drawing upon the universe. Part of Contemporary Performance's inaugural festival, Special Effects, January 9-12, 2014, the festival consisted of six artists from the Contemporary Performance Network, presenting work at The Wild Project in the NYC's East Village and PARTICIPANT INC. Curated by network editors Caden Manson and Jemma Nelson, the four-day festival held panels and artist events, and launched the Contemporary Performance Almanac13 book. Other artists included M. Lamar (NYC); Fitzgerald & Stapleton Dance Theatre (Ireland); Nick Lehane (NYC); and David Commander (NYC).

From March 2 - April 13, 2014, we presented Luther Price, The Years Made Flies, the culmination of Price's larger-than-life figurative work made between 1982-1985. The work in the exhibition marked the end of the artist's preoccupation with sculpture.

MAR. 2 – APR. 13, 2014: Now largely known for his film and performance-based works, the exhibition revealed a prolific period when Price built out his recollections of childhood in the 1960s three-dimensionally. The works on view were made while Price was a student at Massachusetts College of Art and Design, shortly prior to suffering a life-altering gunshot wound in Nicaragua in 1985.

APRIL 27 - JUNE 1, 2014: PARTICIPANT INC presented Erik Moskowitz and Amanda Trager, Two Russians in the Free World, a multi-channel video installation that mapped the interconnections between artistic inspiration, love, and the marketplace. As in their previous collaborative works, music and song are key elements, conveying a narrative derived from actual interviews; in this case, five hours of interview footage with Sasha Jampolsky, who plays the character Sasha, detailing his stories about being an artist in 1970s Soviet Union.

JUNE 8 - JULY 13, 2014: PARTICIPANT INC presented Part Two, a solo exhibition of twelve paintings by Michael Lazarus, made between 2011 and 2014. These mixed media panels made of paint, wood, glass, adhesive lettering, and, in some cases, plastic reflectors and other found materials, share a vocabulary of pared down imagery, color, and response to materials culled from the artist's everyday surroundings.

Modest in size, Lazarus envisions these panels in relationship to the body, where paint and found materials cohabitate and lean into each other. Each work presents itself as a possible painting, sculpture, portrait, mirror, sign, grave marker.

JULY 20 - AUGUST 17, 2014: PARTICIPANT INC presented Zoe Beloff, The Days of the Commune, an installation based on Beloff's restaging of Bertolt Brecht's eponymous play. In the spring of 2012, Beloff brought together a group of actors, activists, and artists to perform the play in solidarity with Occupy Wall Street (OWS). Thinking about OWS as a radical theater of the people, the group conceptualized the project as

a "work in progress," in the sense that all social movements are a work in progress. Rather than stage the play in a theater, The Days of the Commune was performed, scene by scene, in public spaces around New York City, from Zuccotti Park to an East Village community garden. Related public events included a brief history of the Paris Commune by Mitchell Abidor followed by a discussion with the Zoe Beloff and cast members led by curator/writer Niels van Tomme.

SEPTEMBER 7 - OCTOBER 12, 2014: PARTICIPANT INC opened its thirteenth season with NEGROGOTHIC, A Manifesto, The Aesthetics of M. Lamar. This was the first New York solo exhibition by artist, countertenor, and composer, M. Lamar, and features video, still photographs, and sculptural props used in Lamar's films. Most known for his music and performance-based work, this physical installation cross-references romanticism, surrealism, horror, pornography, gospel, metal, and early silent film to propose radical potentialities of blackness. Special events in conjunction with the exhibition included: Laverne Cox and M. Lamar in conversation as part of the GenderFluid festival at Baruch Performing Arts Center on September 9; and a performance of Lamar's song cycle The Tree of Blood, A Requiem on Oct. 5.

OCTOBER 15-19, 2014: PARTICIPANT INC staged an ephemeral exhibition of materials from Chloe Griffin's major publication, Edgewise: A Picture of Cookie Mueller, which was accompanied by a series of events including: Opening Night: Pictures in the Smoke, a book launch and reception celebrating the opening of a four-day exhibit of original material featured in Edgewise on October 15; No Credit, Cash Only: Cookie in Film and Video, a presentation by Dirty Looks NYC's Bradford Nordeen on October 16; and Another Boring Day of Cookie Mueller feat. Richard Hell, Chi Chi Valenti, Sharon Niesp, Max Mueller, Susan Lowe, Max Blagg, Eileen Myles, Patrick Fox, among others on October 19.

NOVEMBER 2 - DECEMBER 21, 2014: We concluded the year with Greer Lankton, Love Me, an exhibition organized in cooperation with the Greer Lankton Archives Museum (G.L.A.M.). This was the first major New York solo exhibition of Lankton (1958-1996) since her death. Representing the scope of Lankton's work with nearly 100 of Lankton's dolls, photographs, and works on paper, LOVE ME was structured by a selection of photographs by friends and peers including Nan Goldin, Timothy Greenfield-Sanders, Peter Hujar, Eric Kroll, Zoe Leonard, Paul Monroe, Daryl-Ann Saunders, Kate Simon, and Geoff Spear; films by Joyce Randall Senechal and Nick Zedd; as well as ephemeral material.

THROUGHOUT THE YEAR: PARTICIPANT INC presented additional programming including: launching of Issue 15 of San Francisco Art quarterly; hosting, with Triple Canopy, a collection visit to the home of Barbara and Howard Morse; and participation in FRIEZE LES & Soho.
