Camp sessions take place in three locations Western North Carolina (Camp Harrison in Boomer, NC), near Atlanta, Georgia (Camp Twin Lakes in Rutledge, GA), and near Columbus Ohio (Recreation Unlimited in Ashley, OH) Camps were leased for one-week programs in March, September and October The website is maintained for camper sign-up and for recruitment of volunteers There is extensive planning for camp sessions for adults with developmental disabilities The Georgia camp session was held March 17-21, 2014, and served 51 disabled adults with help from 55 volunteers The Ohio camp session was held September 7-11 and served 45 disabled adults with help from 52 volunteers The first North Carolina session was held October 4-8, 2014 and served 61 disabled adults with help from 54 volunteers The second North Carolina session was held October 11-15, 2014 and served 60 disabled adults with help from 54 volunteers
