Feeding Pets of the Homeless believes in the healing power of companion pets and of the human/animal bond which is very important in the lives of many homeless. They find solace, protection and companionship through their pets. They care for their pets on limited resources so they themselves have less. Our task, nationwide, is to feed and provide basic emergency veterinary care to their pets and thus relieve the anguish and anxiety of the homeless who cannot provide for their pets.

Pet Food, Supplies and Sleeping crates - non-cash awards of 197,337 lbs of pet food and supplies (FMV = \$387,618) were distributed to non-profit organizations (mostly food banks) across the country to assist with the feeding of pets belonging to the homeless and poor. Pet food and supplies that were purchased by POTH were given to non-profits and/or directly to the homeless. Plus allocatable expenses of \$38,676

**4b** (Code ) (Expenses \$ 77,039 including grants of \$ ) (Revenue \$ )

Emergency Veterinary Care payments of \$57,791 to 75 hospitals/clinics in 17 states to assist emergency treatment to 307 pets of homeless persons. Plus allocatable expense of \$19,248. All treatment expenses are paid directly to the hospitals, not to individuals.

Wellness Clinics - funding of \$20,105 to 13 hospitals/clinics or non-profits in 6 states that performed 41 wellness clinics in various states to 1,216 pets. Wellness clinics include a basic exam and vaccinations. Sometimes with spay/neuter (24 pets) done at the location of the clinic. The sponsorship requires that reporting be done within 120 days from the date of the clinic. Those that take place after September may not be reported until 2015. Plus allocatable expenses of \$19,248
