The Awards for 2014 were as follows: Professional Photographer \$15,000 Grand Prize; Emerging Photographer \$5,000 Grand Prize. Two runner-ups and honorable mentions will be announced in each category but will not receive cash prizes. PhotoPhilanthropy emphasizes the important role of high quality documentary photography and visual storytelling as a vehicle to create meaningful impact and social change.
