secure funding to pay for the ramps.

In the 8½ years of our existence we have raised \$28 million in grants and donations, utilized \$6 million of in-kind donation of services and facilities, and received \$560 thousand in third party payments for ramps constructed. These resources funded the start-up and development of 30 regional operations using volunteer labor to construct almost 6,100 ramps at no cost to the recipients. In 2014, volunteers built 1,535 ramps. Year to year growth has been solid and consistent and is expected to continue throughout 2015.
