In 2014 Northeast Wisconsin Land Trust monitored all of our 42 properties protected by conservation easements. We began a two-year process of Strategic Conservation Planning that will guide our future land acquisition activities. We conducted restoration activities on our Guckenbergs-Sturm Preserve that included the removal of invasive plants and replanting native plants. Working with a private landowner we put a conservation easement on 190 acres in Marinette County now known as Spikehorn Creek Conservancy. The easement protects 1,500 feet of frontage on Spikehorn Creek, a Class 1 trout stream, and its wetlands and uplands. Preservation of this land maintains existing conditions including water quality of an important trout stream, land uses, native plant communities and wildlife populations. The property provides an accessible locale for the observation, study, and general viewing of the operation of, and scenic enjoyment of the watersheds, and their animal and vegetative inhabitants. Spikehorn Creek is designated an Area of Special Natural Resource Interest (ANSRI), a Priority Navigable Waterway (PNW) and an Outstanding Waterbody by the Wisconsin Department of Natural Resources. Northeast Wisconsin Land Trust also conducted a fee title purchase of a 31 acre wetland located in the Town of Suamico in Brown County. This purchase was funded in part by grants from the Knowles-Nelson Stewardship Program and the Fox River/Green Bay Natural Resource Trustee Council. Acquisition of this property protects some of the remaining forested wetlands and cattail marsh habitat that still exists in lower Green Bay and acts as a critical, near shore, water filter. This habitat provides spawning habitat for Northern Pike and a stopover site for migrating birds. This is the seventh nature preserve we have opened to the public for hunting, fishing, trapping, hiking and bird watching. The preserve now protects a Land Legacy Place (Green Bay West Shore Wetlands), and a critical component of the Green Bay West Shores Wildlife Area a Conservation Opportunity Area (COA), for which no other protection options are available.
