During our 2013-2014 school year, we served 510 students in our core programs Our Fellows program served 356 students, with our largest to-date incoming 11th grade class of 83, and an additional 154 students in our 9th grade program Our recruiting schools now number 130 98% of our high school seniors were accepted to four-year colleges, 98% had their demonstrated financial aid need met through scholarships and loans and 53% are matriculating at top colleges such as Amherst, Bowdoin, Brandeis, Carnegie Mellon, Columbia, Dartmouth, MIT, Mount Holyoke, Northwestern, Smith, Wellesley and Williams We have established new partnerships with colleges, for example, Lafayette and Connecticut Colleges These arrangements facilitate admission and financial support to a select group of our students Summer internships and enrichment programs serve as critical skill building and personal development opportunities for our Fellows For the five summers that students are with us, we help them identify, prepare and apply for opportunities Students have mandatory check-ins to ensure that their summer is meaningful and productive Our list of corporate and nonprofit internship partners continues to grow As our number of in-college students increases, we are evolving our curriculum and support mechanisms to ensure that they remain on track to graduate and be successful after college We doubled the number of workshops offered during our Summer College Success Series, from nine to 18, and added a new version of Career Transition sessions Programs further developed work skills, career exposure and networking opportunities Volunteer companies included Capital One, Centerbridge Foundation, Facebook, Gerson Lerhman Group, Goldman Sachs and Reddit
