Our principal focus was to begin operationalizing 3 pilot programs anticipated to launch in Spring 2015. This required collaborating with medical school alumni associations, identifying, interviewing and engaging with safety-net clinics, identifying, interviewing and engaging technology collaborators, addressing issues of malpractice insurance and credentialing and creating a web presence to attract volunteer physicians, clinics and others. It is estimated that 75% of all 1099 and expenses were directly attributable to this program service. The remaining 25% were operational activities.
